

Ordinance No. G-02-09

**AN ORDINANCE PROVIDING ADDITIONAL
COMPENSATION FOR THE TOWN MARSHALL
AND DEPUTY MARSHALLS**

BE IT ORDAINED BY THE TOWN COUNCIL OF GEORGETOWN,
INDIANA THAT:

WHEREAS, pursuant to Indiana Code 36-5-3-2, the Council for the Town of Georgetown is the entity responsible for determining the compensation for the Town Marshall and Deputies; and

WHEREAS, the Council is desirous of compensating the Town Marshall and Deputies for the hours worked above and beyond an average forty (40) hour work week; and

WHEREAS, the Council is desirous of reimbursing the Town Marshall and Deputies for the expenses associated with dry cleaning their uniforms; and

WHEREAS, the Council is desirous of compensating the Town Marshall and Deputies for certain Holidays which are not taken by the officers throughout the year.

NOW, THEREFORE, BE IT ORDAINED, that the following forms of additional compensation shall be paid to the Town Marshall and Deputies:

1. The Town Marshall and Deputies shall be paid additional compensation in the form of a bonus at the end of each calendar year. The amount of the bonus for each employee of the Town Marshall's Office shall be calculated by dividing the employee's gross weekly salary by forty (40) and multiplying the result times one hundred fifty-six (156); and


2. The Town Marshall and Deputies shall be reimbursed an amount of Two Hundred Fifty and 00/100 Dollars (\$250.00) for Uniform cleaning expenses at the end of each calendar year; and
3. The Town Marshall and Deputies shall be compensated for up to six (6) scheduled Holidays at a rate of eight (8) hours per day, excluding vacation or sick days, which were not taken by the officers; and
4. Payment and entitlement of said forms of compensation and reimbursement shall be contingent upon the individual's employment status as of December 31st of the calendar year for which said additional compensation and reimbursement shall be paid. Any employee who is not employed with the Town Marshall's Office as of the determination date (December 31st) shall not be entitled to any compensation mentioned herein. An employee of the Town Marshall's Office who begins employment during the year for which compensation shall be paid shall receive a prorated share of said compensation according to his/her hire date.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its adoption.
