ORDINANCE REGULATING PARKING,
UNLICENSED VEHICLES, AND TRAFFIC

BE IT ORDAINED by the Board of Trustees of the Town of Georgetown, Floyd County, Indiana, that:

1. This ordinance shall amend all applicable provisions of a prior ordinance passed October 19, 1972 regulating the parking of vehicles or animal driven carriages along State Road 64.
2. It shall be unlawful for an operator of a motor vehicle or of an animal driven carriage to park the same on the North side of State Road 64 or Main Street within the Town of Georgetown, from Canal Street to the Georgetown-Lanesville Road.
3. It shall be unlaw for an operator of a motor vehicle or animal driven carriage to park the same other than parallel with the edge of the road and with the wheels not less than 6 inches off the edge of the road.
4. No parking shall be permitted within twenty feet of any intersection along said Highway 64 nor shall any parking be allowed that would block driveways or ingress or egress from residential or commercial properties.
5. No parking shall be permitted within twenty feet of any fire hydrant.
6. No unlicensed vehicles shall be parked on any street within the town limits of the Town of Georgetown, Floyd County, Indiana. An unlicensed vehicle will be considered an abandoned vehicle under the statutes of the State of Indiana if said vehicle is left unattended and unlicensed for a period exceeding 24 hours.
7. It shall be unlawful for any vehicle over the length of twenty feet to be parked on any public thoroughfare, street, road or alley within the corporate limits of the Town of Georgetown, between the hours of 7:00 P.M. and 7:00 A.M.

8. No parking shall be allowed on any sidewalks within the town limits of the Town of Georgetown.
9. No vehicle shall exceed the speed limit of 20 miles per hour on any street within the town limits of the Town of Georgetown. All alleys shall have a speed limit of 10 miles per hour and no vehicle shall exceed said 10 mile per hour limit.
10. Any person who shall violate any section of this ordinance shall be guilty of a misdemeanor and upon conviction shall be fined in a sum not less than \$1.00 nor more than \$50.00 for each offense.
