ORDINANCE OF ANNEXATION

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE TOWN OF GEORGETOWN, COUNTY OF FLOYD, STATE OF INDIANA, PURSUANT TO THE PROVISIONS OF I.C. 36-4-3-1, BY ANNEXING THERETO THOSE AREAS DESCRIBED IN THE ATTACHED EXHIBIT "A" AND REFERRED TO IN A CERTAIN ANALYSIS AND FISCAL PLAN REPORT READOPTED BY RESOLUTION BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA, ON THE 11TH DAY OF MARCH, 1991, SAID AREA CONTIGUOUS TO AND NOT EMBRACED WITHIN THE PRESENT LIMITS OF THE TOWN OF GEORGETOWN;

PREAMBLE

That in order to provide services to the areas to be annexed, including but not limited to, sewage service as directed by the Federal Environmental Protection Agency and the Indiana Department of Environmental Management, the Town has expressed a desire to have the property referred to above and attached hereto as Exhibit "A" brought within the corporate limits by annexation, the Town Board does ordain as follows:


Section I: The Town Board of Georgetown does hereby determine that the real property proposed for annexation (see Exhibit "A") does satisfy the statutory requirements of the Indiana Code in terms of the sufficiency of its being contiguous to the present corporate limits, and as such the Town Board has jurisdiction to annex said property to the Town of Georgetown.


Section II: The corporate limits of the Town of Georgetown are hereby extended and increased so as to include and embrace within the corporate limits of the Town of Georgetown the real estate described in Exhibit "A" herein and such real estate is herein and such real estate is hereby annexed and declared to be a part of the Town of Georgetown.


Section III: On the filing and recording of the copy of this Ordinance, in the Office of the County Recorder of the County of Floyd, State of Indiana, the fee simple title of all streets and roads shall vest in the Town of Georgetown.






