

Ordinance No. G-92-13

**AN ORDINANCE CONCERNING THE EXECUTION OF AN AGREEMENT  
BETWEEN THE TOWN OF GEORGETOWN AND THE CITY OF  
NEW ALBANY FOR SEWAGE TREATMENT SERVICES**

Whereas, the Town of Georgetown (the "Town") has heretofore expressed the intent to build a sewage works collection system pursuant to Ordinance No. G-92-07, An Ordinance Concerning Establishment of a Sewage Works, The Construction of And Additions and Improvements to the Sewage Works of the Town of Georgetown, The Issuance of Revenue Bonds to Provide the Cost Thereof, The Collection, Segregation and Distribution of the Revenues of Said Works, The Safeguarding of the Interests of the Owners of Said Bonds, Other Matters Connected Therewith, and Repealing Ordinances Inconsistent Therewith, dated May 21, 1992; and

Whereas, the plans and specifications prepared by Commonwealth Engineers, Inc., consultants to the Town, provide for the treatment of services of said sewage works to be provided by the City of New Albany; and

Whereas, it is necessary to enter an agreement with the City of New Albany for said treatment services and said agreement shall be for a period of not less than the term of the revenue bonds issued for said construction; and


Whereas, the Town and City of New Albany have agreed upon said terms and have provided for the payment of a portion of the revenues of the sewage works of the Town to the City of New Albany for the payment of said treatment services;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA AS FOLLOWS:


1. That the Town does hereby accept, approve, and enter into the Sewage Treatment Agreement Between the City of New Albany, Indiana and The Town of Georgetown, Indiana for Sewage Treatment Services, dated the 13th day of August, 1992 (the "Agreement"), incorporated herein and made a part hereof.
2. The Town Council acting as and on behalf of the municipal works board is authorized to sign the Agreement and submit said Agreement to the Indiana Department of Environmental Management for approval.




