

ORDINANCE NO. G-94-23

ORDINANCE AMENDING ORDINANCE NO. G-93-08 PROVIDING FOR AN INCREASE IN THE AMOUNT OF PAID VACATION TIME FOR THE CLERK/TREASURER AND THE OFFICERS AND EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA AND THE GEORGETOWN WATER UTILITY AND SEWER UTILITY.

BE IT ORDAINED BY THE TOWN COUNCIL OF GEORGETOWN THAT:


WHEREAS, the Council for the Town of Georgetown is the entity responsible for fixing of compensation, benefits, Vacation and sick days for the Clerk/Treasurer of the Town, and the Town police officer (hereinafter "officers") and employees, and also the employees of the Georgetown Water Utility and Georgetown Sewer Utility; and

WHEREAS, Ordinance No. G-93-08 provides that Clerk/Treasurer, officers and employees of the Town of Georgetown, the Water Utility or Sewer Utility are entitled to (1) week of paid vacation after one (1) year of consecutive employment, and are entitle to two (2) weeks of paid vacation after two (2) or more consecutive years of employment, and are entitled to three (3) weeks of paid vacation after eight (8) years of consecutive employment.

NOW, THEREFORE, BE IT FURTHER ORDAINED, the Clerk/Treasurer, any officer or employee of the Town of Georgetown, the Water Utility or Sewer Utility shall be entitled to one (1) additional day paid vacation for each consecutive year of employment over and above two (2) consecutive years of employment up to but not exceeding 15 days paid vacation.


BE IT FURTHER ORDAINED, that any portion of Ordinance No. G-93-08 or any other Ordinance of the Town of Georgetown presently in effect, which conflicts with this Ordinance, shall be null and void and be deemed modified in accordance with the resolutions herein; additionally, any portions of any of the aforementioned Ordinances, or any other ordinance of the Town of Georgetown, presently in effect which do not conflict with the provisions of the Ordinance, shall be in full force and effect.
