

ORDINANCE NO. G-96-02

**AN ORDINANCE FOR THE APPOINTMENT OF  
RESERVE DEPUTIES TO THE MARSHAL'S  
DEPARTMENT AND FOR MANDATED TRAINING REQUIREMENTS.**

WHEREAS, the Town of Georgetown Marshal's Department has used (special) reserve deputies in the past to supplement the Marshal's Department in terms of man-power to adequately protect the health, safety, and well being of the inhabitants of its town, and

WHEREAS, the Town Council of Georgetown, Indiana wishes to conform to Indiana state statues pertaining to the appointment and training of (special) reserve deputies now find it desirable to establish a limited number of (special) reserve deputies positions and do HEREBY authorize the Town Marshal to fill these positions as per I.C. 36-8-3-20.

WHEREAS, the Town Council wishing to conform to Indiana statue does now HEREBY order the Town Marshal to conform all training of reserve deputies to I.C. 4-22-2 (pre-basic) mandated training and completion of 40 hours of pre-service training prior to any participation in departmental training, and as per Indiana Code I.C. 36-8-3-20 which requires a reserve officer to complete the agencies training and probationary period as per department rules before he can be appointed.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Georgetown, Floyd County, Indiana, that:

SECTION 1. There is hereby established the office of reserve deputy to be appointed by the Town Marshal and to serve under the Town Marshal. Reserve deputies serve at the pleasure of the Town Marshal and must be reappointed if there is a change in the office of the Town Marshal.

SECTION 2. Any person that makes an application for appointment as a reserve deputy shall have a background investigation done. This background investigation shall consist of a NCIC/IDACS FILE check, local criminal history check, local warrant check (22/31/93/13/72/88) and any out of state location at which the applicant may have resided for any period of time. A investigation as to the applicants driving history shall also be done. A file shall be kept on each appointee to attest his or her background investigation was completed.

SECTION 3. The number of reserve deputies shall be limited to six(6).

SECTION 4. Reserve deputies shall serve without remuneration of any type.

SECTION 5. Reserve deputies shall be added to the departments liability insurance plan.

SECTION 6. Reserve officers be required to participate in a continuing education program after completing the basic department training.


SECTION 7. All ordinances or resolutions, or parts of ordinances or resolutions, in conflict herewith are hereby repealed. The invalidity of each section, clause, sentence, or provision of this ordinance shall not affect the validity of any other part of this ordinance which can be given effect without such invalid part or parts.

SECTION 8. This ordinance shall be in full force and effect from and after its passage.




