

ORDINANCE NO. G-96-08

AN ORDINANCE PROVIDING FOR THE COMPENSATION OF THE TOWN SUPERINTENDENT AND ASSISTANT SUPERINTENDENT, AND NAMING PERSONS TO FILL SAID POSITIONS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA THAT:

WHEREAS, the Town Council is the entity responsible for hiring employees of Georgetown's water utility department, sewer department and all other departments and for the fixing of compensation for any and all employees of said departments;

WHEREAS, after due consideration and discussion it was agreed that below names shall be named, respectively, to the positions of Georgetown Superintendent and Georgetown Assistant Superintendent, with the below set probationary periods, and shall receive the following compensation;

NOW THEREFORE BE IT RESOLVED that the following employees shall be named as Town Superintendent and the Assistant Superintended of the Town of Georgetown:

Robert L. Chase, Town Superintendent

Ray Ogle, Assistant Town Superintendent

NOW THEREFORE BE IT FURTHER RESOLVED that pursuant to Ordinance No. G-96-02, the six month probationary period for Robert Chase shall expire on July 1, 1996, and that Ray Ogle shall have a probationary period of six months form the date of this Ordinance as the Town's Assistant Superintendent; however, this is in no way to be construed as a probationary period for Ray Ogle as an employee but only a probationary period for him holding the position of Assistant Town Superintendent.

NOW THEREFORE BE IT FURTHER RESOLVED that the following positions with the Town of Georgetown shall receive the following hourly wage:

Town Superintendent \$8.50/hr; and

Assistant Town Superintendent \$8.50/hr.


NOW THEREFORE BE IT FURTHER RESOLVED that if for any reason Ray Ogle relinquishes, or is terminated from, his position as Assistant Town Superintendent, but is still retained in the employment of the Town, he will revert to the then existing hourly rate for a general laborer of the Town.

NOW THEREFORE BE IT FURTHER RESOLVED that any part or section of any Ordinance of the Town that is in conflict with this Ordinance shall be, and hereby is, repealed.

This Ordinance shall be effective beginning June 28, 1996.


