AN ORDINANCE AMENDING ORDINANCE NO. G-17-7, AN FIXING SALARIES AND WAGES OF OFFICERS AND EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA FOR CALENDAR YEAR 2018.

WHEREAS, pursuant to Indiana Code 36-5-3-2, the town legislative body wishes to set the salaries and wages for officer and employees of the Town for calendar year 2018.
