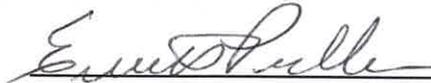
Josh Cavanaugh has a replacement for Patti Denison on the Storm Water Board if needed.

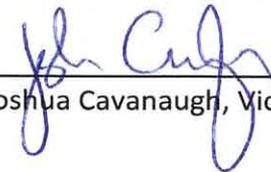

Kathy Haller made a motion to adjourn the meeting. Seconded by Josh Cavanaugh and approved 5-0.

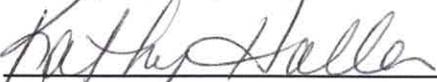
