ORDINANCE NO: G-12- 1

## AN ORDINANCE ESTABLISHING A DEPARTMENT OF STORM WATER MANAGEMENT AND STORM WATER BOARD OF DIRECTORS FOR THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Town Council of the town of Georgetown, Indiana desires to establish a Department of Storm Water Management to provide management and oversight of storm water in the town of Georgetown, Indiana in an effort to protect and ensure the public health and safety of the residents of the town of Georgetown, Indiana; and

WHEREAS, the Town Council of the town of Georgetown, Indiana has authority to create such Department of Storm Water Management and operate said department pursuant to the applicable provisions of the Indiana Code.

## NOW THEREFORE, BE IT ORDAINED AS FOLLOWS:

- 1. The Georgetown Department of Storm Water Management and Georgetown Storm Water Board are hereby established.
- 2. The provisions of Indiana Code Chapter 8-1.5-5 et. seq. are hereby adopted and incorporated hereto by reference.
- 3. The Georgetown Department of Public Works shall operate as the Department of Storm Water Management for all storm water purposes, and shall act at all times pursuant to the direction of the Georgetown Storm Water Board.
- 4. The President of the Georgetown Town Council, as the town Executive, shall appoint three (3) persons to serve as directors of the Georgetown Storm Water Board, with no more than two (2) of such persons being of the same political party.
- 5. The three appointed directors shall be designated to serve initial terms beginning on January 31, 2012 and ending November 30, 2012, 2013 and 2014 as so designated.
- 7. After the initial terms of the directors are completed, each director shall thereafter serve a term lasting for a period of six (6) years, to that terms are staggered as provided under Indiana Coded 8-1.5-5-4(d).

- 8. The Georgetown Storm Water Board of Directors shall have the powers enumerated in Indiana Code 8-1.5-5-4(a) and Indiana Code 8-1.5-5-6.
- 9. A special taxing district is hereby established being comprised of the lands within the corporate boundaries of the Town of Georgetown (the "District").
- 10. The Georgetown Storm Water Board of Directors shall hold hearing to assess and collect user fees with regular town billings in accordance with Indiana Code 8-1.5-5-6 and Ordinance G-06-24, and the Town Council of Georgetown hereby approves assessment and collection of the same according to Ordinance G-06-24.
