ORDINANCE NO: G-12- 06

**AN ORDINANCE AMENDING ORDINANCE G-08-08 AND
SECTION 94.05 OF THE GEORGETOWN CODE OF
ORDINANCES AUTHORIZING THE TOWN TO HOST
AND SPONSOR SOFTBALL LEAGUES AND TOURNAMENTS
TO BE CONDUCTED AT GEORGETOWN PARK**

WHEREAS, the Town Council of the Town of Georgetown, Indiana desires to continue promoting the use of the Town's park system for the benefit of the citizens of Georgetown and visitors to Georgetown, and

WHEREAS, The operation of the park system also includes management of the Town's softball league(s) and tournament play, if any; and

WHEREAS, The Town Council of the Town of Georgetown, Indiana desires to modify the current and established manner and operation of softball team play in Georgetown Park; and

WHEREAS, The Town Council has determined that the League Director should manage the organization and operation of the softball leagues, softball teams and softball tournaments in Georgetown Park.

NOW THEREFORE, BE IT ORDAINED AS FOLLOWS:

That Section 94.05 of the Georgetown Code of Ordinances is hereby amended as follows

A. SOFTBALL GAMES, ORGANIZATION AND OPERATION

The League Director is hereby charged with all duties, powers and responsibilities regarding the management, organization and operation of softball teams, leagues and tournaments conducted at Georgetown Park.

B. LEAGUE DIRECTOR

1. Duties and Responsibilities

The League Director duties and responsibilities include, but are not limited to operation of concessions; the hiring and supervision of umpires and scorekeepers as needed, to operate softball games and tournaments; to collect signed releases and waivers

of liability and park alcohol policy forms; and to perform other duties as are necessary for the successful use and promotion of Georgetown Park.

2. Softball Diamond Rental and Preparation

The League Director may rent the softball diamond to organized teams at the rate of \$75.00 per day. All rental fees shall be paid to the Georgetown Clerk/Treasurer. If a rental fee has been paid by a softball team, the softball diamond is reserved for that team's use. If the softball diamond is vacant and has not been rented, the softball diamond may be used by anyone for no charge, provided that paying softball rentals have priority over persons using the softball diamond free of charge.

3. League Director Pay

The League Director shall be paid \$25.00 per rental fee collected for softball diamond preparation. Additionally, the League Director is an independent contractor to the Town and shall be paid at a rate of \$15.00 per game.

C. SOFTBALL TEAM FEES AND PAYMENT OF FEES

1. Effective immediately, the Team Fee for softball teams to play in the Town's Spring League is \$290.00 per team.

2. Effective immediately, the Team Fee for softball teams to play in the Town's Summer League is \$390.00 per team.

~~Spring~~^{FALL} 3. Effective immediately, the Team Fee for softball teams to play in the Town's ~~Spring~~ League is \$290.00 per team.

4. Payment of all Team Fees for league play shall be paid to the Georgetown Clerk/Treasurer.

D. UMPIRE AND SCOREKEEPER PAY

1. Umpires: Umpires hired by the League Director for league or tournament play shall be paid at the rate of \$27.00 per game.

2. Official Scorekeepers: Official scorekeepers shall be paid at a rate of \$7.50 per game.

E. ADVERTISING AND RATES

The Town Clerk/Treasurer is authorized to sell advertising space for any

commercial enterprise that the Clerk/Treasurer deems appropriate.

1. The fee for a 3'x 6' banner with one color ink and no logo, supplied by the Town, which will hang on the outfield fence, facing the grandstand, shall be \$250.00 for one year's exposure. Should the same company desire to renew its advertising for a second or more years and continue to use the same banner, the annual cost to such advertiser shall be \$200.00 for the second or subsequent consecutive years.

2. The fee for a 3'x 6' banner with two color ink and a logo, supplied by the Town, which will hang on the outfield fence, facing the grandstand, shall be \$350.00 for one year's exposure. Should the same company desire to renew its advertising for a second or more years and continue to use the same banner, the annual cost to such advertiser shall be \$200.00 for the second or subsequent consecutive years.


F. CONFLICT WITH OTHER ORDINANCES


