## Ordinance G-12-13

### AN ORDINANCE AUTHORIZING ADDITIONAL APPROPRIATIONS

**WHEREAS**, the Town Council of the Town of Georgetown, Indiana (hereinafter this "Town Council"), is the legislative body of the Town of Georgetown, County of Floyd, State of Indiana (the "Town"); and

**WHEREAS**, there are funds available in the General Fund, EDIT Fund, CCI Fund, Park Fund, and Gaming Fund from unused, appropriated amounts; and

**WHEREAS**, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget; and

**WHEREAS**, the Town Council hereby provides this ordinance to appropriate unused funds from accounts as set forth below.

#### NOW, THEREFORE, BE IT ORDAINED BY THIS TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA, AS FOLLOWS:

Section 1. That for the expenses of the taxing unit, the following additional sums of money are hereby appropriated out of the funds named and for the proposes specified, subject the laws governing the same:
