

ORDINANCE G-12- 17

AN ORDINANCE PROVIDING FOR
ONE-TIME BONUSES FOR THE EMPLOYEES FOR THE
TOWN OF GEORGETOWN, INDIANA

WHEREAS, The Town of Georgetown has received a reimbursement in the amount of Eight Thousand, Seven Hundred Dollars (\$8,700.00) from an insurance policy that the Town of Georgetown no longer owns; and

WHEREAS, the Town Council of the Town of Georgetown, Indiana desires to pay to the employees of the Town of Georgetown a one-time bonus, based on longevity for each employee's service to the Town; and

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown, Indiana has determined that the employees listed below should receive the stated one-time bonus increase in in compensation as listed for each employee position. Further, these bonuses, except for the Town Clerk/Treasurer, and the two Deputy Clerks as marked below shall be paid to each named employee in the year 2012 and shall not be paid to said employees again unless by a separate Ordinance approved by the Georgetown Town Council. The Clerk Treasurer and the Deputy Clerks will receive their one-time bonus on January 1, 2013.

**NOW BE IT ORDAINED BY THE TOWN COUNCIL OF GEORGETOWN,
INDIANA AS FOLLOWS:**

The below designated Georgetown employees shall receive the following one-time bonuses as follows, based on a payment of \$100.00 for each full year of service and \$50.00 for employees who have only been employed by the Town for the partial year of 2012.
