Ordinance G-12-20

AN ORDINANCE PROVIDING FOR A ONE-TIME LONGEVITY BONUS FOR EACH EMPLOYEE FOR THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Town Council for the Town of Georgetown, Indiana desires to pay employees of the Town of Georgetown a one-time bonus, based on longevity for each employee's years of service to the Town; and

WHEREAS, funds are available from the General Fund and Wastewater Operations Fund; and

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown, Indiana has determined that the employees listed below should receive the stated one-time bonus increase in compensation as listed for each employee. Further, these bonuses, shall be paid to each named employee in the Year 2012, and shall not be paid to said employees again unless by a separate ordinance approved by the Town Council.

NOW BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF GEORGETOWN INDIANA AS FOLLOWS:

The below designated Town of Georgetown employees shall receive the one-time longevity bonuses as follows, based on a payment of \$100.00 for each full year of service for full time employees, \$50.00 for each full year of service for part-time employees, and \$50.00 for employees who have been employed by the Town for the partial year of 2012.
