

**ORDINANCE NO. G-12- 22**

**AN ORDINANCE AMENDING ORDINANCE NO. G-02-18  
DEFINING THE VOTING DISTRICTS IN THE TOWN OF  
GEORGETOWN, INDIANA IN ACCORDANCE WITH  
THE 2010 DECENNIAL CENSUS**

WHEREAS, pursuant to I.C. 36-5-2-4.1, the Town Council of the Town of Georgetown, Indiana is the entity responsible for establishing voting districts within the Town and the boundaries of said voting districts for the purpose of the election of town officers; and

WHEREAS, pursuant to I.C. 36-5-2-4.1, the Town Council of the Town of Georgetown is required to redefine the voting districts within the Town of Georgetown in the year 2012 and every ten (10) years thereafter; and

WHEREAS, the Town Council of the Town of Georgetown last defined the voting districts within the Town of Georgetown in the year 2002 by Ordinance No. G-02-18; and

WHEREAS, the Town Council of the Town of Georgetown had endeavored to define the boundaries of the voting districts in order to equalize the population of each of the three (3) voting districts as much as possible based upon the 2010 decennial census data, and that the crossing of precinct lines has had to be implemented to equalize the population of each voting district as closely as possible.

NOW, THEREFORE, BE IT ORDAINED that Ordinance G-02-18 defining the voting districts of Georgetown, Indiana is AMENDED AS FOLLOWS:

**DISTRICT ONE**

Beginning at the Northwest Boundary for the Town of Georgetown, the TRUE POINT OF BEGINNING for District One of the Town of Georgetown, Indiana; Thence East along said Northern Boundary of Georgetown to the Northwest side of Kepley Road; Thence South along the West side of Kepley Road to the Southwest corner of Kepley Road and Autumn Drive. Thence East by Southeast along the Southwest side of Autumn Drive to the Southeast side of the intersection of Autumn Drive and State Road 64; Thence East along the South side of State Road 64 to the West side of Canal Lane; Thence South on the West side of Canal Lane to the Southern Boundary of the Town of Georgetown; Thence West along the Southern Boundary of the Town of Georgetown; Thence North along the Western Boundary of the Town of Georgetown to the Northwest Boundary for the Town of Georgetown, the TRUE POINT OF BEGINNING for District One for the Town of Georgetown, Indiana.

**DISTRICT TWO**

Beginning at the Northern Boundary of the Town of Georgetown at the Southeast corner of Kepley Road and Bennett-Kelly Way, the TRUE POINT OF BEGINNING for District Two of the Town of Georgetown, Indiana; Thence South along the East side of Kepley Road to the Northeast corner of Kepley Road and Autumn Drive; Thence East by Northeast along the Northeast side of Autumn Drive to the Northeast side of Autumn drive and State Road 64; Thence East along the North side of State Road 64 to the Southwest corner of Henriott Road and State Road 64; Thence North along the West side of Henriott Road to the Northeast corner of Henriott Road and Frank Ott Road; Thence West on the North side of Frank Ott Road to the Northwest side of Frank Ott Road and Cedar Circle; Thence North 2,700' feet; Thence West 1,800' feet; Thence South 2,700' to the Northeast corner of Henriott Road and Frank Ott Road; Thence West along the Northern Boundary of the Town of Georgetown to the Southeast corner of Kepley Road and Bennett-Kelly Way, the TRUE POINT OF BEGINNING for District Two for the Town of Georgetown, Indiana.


**DISTRICT THREE**

Beginning at the Southeast corner of Canal Lane and State Road 64, the TRUE POINT OF BEGINNING for District Three of the Town of Georgetown, Indiana; Thence South on the West side of Canal Lane to the Southern Boundary of the Town of Georgetown; Thence East along the meandering Southern Boundary of the Town of Georgetown to the Eastern Boundary of the Town of Georgetown; Thence North along the Eastern Boundary of the Town of Georgetown in a meandering path to the Northwest corner of Ridgeway Drive and the Northern Boundary of the Town of Georgetown; Thence East in a meandering path, continuing to the Southwest corner of Frank Ott Road and Henriott Road; Thence South along the East side of Henriott Road to the South side of State Road 64; Thence West along the South Side of State Road 64 to the Southeast corner of Canal Lane and State Road 64, the TRUE POINT OF BEGINNING for District Three for the Town of Georgetown, Indiana.
