Ordinance No. G-15-08

AN ORDINANCE ESTABLISHING THE RENTAL AND USE OF
HOSE BIBB METERS FOR THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, The Town Council for the Town of Georgetown, Indiana desires to allow the Customers the use of and rental of Hose Bibb Meters for reading water usage.

WHEREAS, The Town Council for the Town of Georgetown, Indiana desires to allow the Customers to have the option of a seasonal, monthly or short term rental of the Bibb Meter.

WHEREAS, The Town Council for the Town of Georgetown, Indiana desires to allow Customers to receive a credit for the charged sewer usage on their utility bill after the return of the Bibb Meter.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF GEORGETOWN, INDIANA AS FOLLOWS:

1. That the Hose Bibb Meters will be available for Customers to rent from May 1 through September 30.
2. That the Hose Bibb Meters will be made available for seasonal, monthly, or short term rentals (all days are considered calendar days unless specified otherwise).
 - a. Seasonal rentals will run from May 1 through September 30 (5 months) and shall be at a rate of \$5.00 per month (30 days).
 - b. Monthly rentals shall run for a period of eight (8) days to thirty (30) days and shall be at a flat rate of \$10.00 for usage of eight (8) to thirty (30) days.
 - c. Short Term rentals shall run for a period of seven (7) days or less and shall be at a flat rate of \$5.00 for the usage up to seven (7) days.
3. That Customers must pay an eighty dollar (\$80) security deposit for the Hose Bibb Meters. The security deposit shall be returned to the Customer, in either the form of a check or a credit to their utility bill, once the Hose Bibb Meter has been returned and it has been verified to contain no damage.
4. That the Customer shall receive a credit to their sewer account on their NEXT utility billing period following the return of the Hose Bibb Meter. The credit will not occur during the use or term of the rental of the Meter.
5. That the Clerk or Designee shall mark the Meter reading before and after the rental of the Hose Bibb Meter, on the Rental Agreement, to allow for the calculation of the amount of water that did not enter the sewer system to determine any credit owed the Customer.

6. That all Hose Bibb Meter rentals shall require the execution, containing the signature of the Customer renting the Meter, of the "Water Meter Rental Agreement."
7. That the "Water Meter Rental Agreement" shall set out the terms of the rental period. No credit shall be issued by the Town until said period has terminated and a calculation has been completed to determine any credit owed the Customer.
