TOWN OF GEORGETOWN, INDIANA ORDINANCE NO. G-15-25

AN ORDINANCE TO FORMALLY ADOPT AND ACCEPT ROADS WITHIN THE PROPERTY OF GUERIN, INCORPORATED, FOR THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Georgetown Town Council for the Town of Georgetown, Indiana has caused the roadways known as Tract #1 (Sister Barbara Way), Tract #2 (Cristiani Way extension 1), and Tract #3 (Cristiani Way extension 2) within the campus of Guerin, Incorporated, in the Town of Georgetown to be inspected.

WHEREAS, said roads were designed to be publicly dedicated roads.

WHEREAS, the Georgetown Town Council for the Town of Georgetown, Indiana desires to accept the public dedication of said roads from Guerin, Incorporated, developer of Guerin campus.

NOW THEREFORE, be it ordained by the Town Council of Georgetown, Indiana that:

SECTION 1. The property described in Attachment "A" (Legal Descriptions) and depicted in Attachment "B" (Right of Way Plat) is hereby accepted and dedicated to the public's use as Sister Barbara Way and Cristiani Way.

These are "new roads" or "road extensions" for reporting purposes to the Indiana Department of Transportation (INDOT) for inventory and tax purposes.

SECTION 2. These roads shall be reported by the Public Works Director to the INDOT/Office of Asset Management and Road Inventory, either electronically or by certified mail.

This ordinance shall be in full force and effect as of the date of adoption by the Town Council.


