TOWN OF GEORGETOWN, INDIANA ORDINANCE NO. G-15-20

AN ORDINANCE FIXING SALARIES AND WAGES OF OFFICERS AND EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA FOR CALENDAR YEAR 2016.

WHEREAS, pursuant to Indiana Code 36-5-3-2, the town legislative body wishes to set the salaries and wages for officers and employees of the Town for calendar year 2016.

WHEREAS, pursuant to Indiana Coe 36-5-3-2, the town legislative body wishes to set the hire in rate of salaries and wages for new officers and employees of the Town.

NOW THEREFORE, be it ordained by the Town Council of Georgetown, Indiana:
