

AN ORDINANCE FIXING SALARIES AND WAGES OF OFFICERS AND EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA FOR CALENDAR YEAR 2018.

WHEREAS, pursuant to Indiana Code 36-5-3-2, the town legislative body wishes to set the salaries and wages for officer and employees of the Town for calendar year 2018.

WHEREAS, pursuant to Indiana Code 36-5-3-2, the town legislative body set the hire in rate of salaries and wages for new officers and employees of the town previously in Ordinance G-15-26 Section II and those will remain unchanged and G-15-26 Section II will remain in effect.

NOW THEREFORE, be it ordained by the Town Council of Georgetown, Indiana:

SECTION I – CURRENT EMPLOYEES WAGES AND SALARIES

That, from after the first day of January 2018, the current employees of the Town of Georgetown, Indiana as of January 1, 2018 shall receive the wages/salaries listed below to the right of their name and position. The wages/salaries listed below includes the 2.0% cost of living raise approved by the Town Council for calendar year 2018. Said cost of living increase applies to current Town employees but does not apply to elected officials or the Deputy Building Commissioner/Zoning Administrator as stated in Ordinance G-15-12. *Also excluded from the 2.0% increase is Patrolman Class B, as this position was just hired and not eligible for the increase and any vacant positions.

The Town Council will receive the salaries listed below beginning January 1, 2018. The salaries listed for the Town Council includes a 2% raise for all Town Council Positions.




