

ORDINANCE NO. G-01-10

**AN ORDINANCE AMENDING ORDINANCE NO. G-99-02
RELATING TO PROVIDING AN INCREASE
IN WATER UTILITY RATES**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF
GEORGETOWN, INDIANA, THAT:

WHEREAS, the Town Council is the entity responsible for fixing and approving new rates and charges for the Georgetown Municipal Water Utility pursuant to I.C. 8-1.5-3 et seq.;

WHEREAS, after due consideration and discussion it was agreed that the current schedule of water rates is now inadequate to provide enough revenue for the costs and expenses necessary to operate and maintain the water utility and to improve the water services available to residents; and

WHEREAS, after due consideration and discussion it was further agreed that the water rates will be amended as set forth below;

NOW, THEREFORE, BE IT ORDAINED, that Ordinance No. G-99-02 is amended to provide that the following rates and charges be adjusted, after a public hearing held in accordance with I.C. § 8-1.5-3-8.1, as follows:

NOW, THEREFORE, BE IT FURTHER ORDAINED, that in accordance with I.C. 8-1.5-3-8.1, after the introduction of this ordinance, but before this ordinance is finally adopted, the Town Council shall hold a public hearing at which the users of the

Georgetown Municipal Water Utility, owners of property served or to be served by the Georgetown Municipal Water Utility, and other interested persons may be heard concerning the proposed rates and charges as set forth herein. Notice of the hearing shall be published in accordance with I.C. 5-3-1 et seq. and mailed in accordance with I.C. 8-1.5-3-8.1. After the hearing, the Town Council shall adopt this ordinance, either as originally introduced or as modified. A copy of the schedule of rates and charges adopted herein shall be kept on file and available for public inspection at the offices of the Town Council and Town Clerk/Treasurer.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that upon final adoption of adjusted rates, the adjusted rates will take effect the 1st day of January, 2002, unless delayed in accordance with I.C. 8-1.5-3-8.2 which allows owners of property connected or to be connected to and served by the Georgetown Municipal Water Utility to file a written petition objecting to the rates and charges set forth herein so long as (1) the petition contains the names and addresses of the petitioners; (2) the petitioners attended the public hearing provided under I.C. 8-1.5-3-8.1; (3) the written petition is filed with the Town Council within five (5) days after the ordinance is adopted pursuant to I.C. 8-1.5-3-8.1; and (4) the written petition states specifically the ground or grounds of objection.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that upon the effective date of the Ordinance herein, any provisions of Ordinance No. G-99-02 which are in conflict with this amendment are hereby repealed, and that any provisions of Ordinance No. G-99-02 which are not in conflict with this amendment shall remain in full force and effect.





TARIFF OF RATES AND CHARGES

For the use of and the service rendered by the water utility of the Town of Georgetown, Indiana, the following rates and charges are based upon the amount of water supplied by said water utility.

(a) <u>Consumption Per Month</u>	<u>Rate Per</u> <u>1,000 Gallons*</u>
First 3,000 gallons	\$7.0892
Next 3,000 gallons	4.8734
Next 4,000 gallons	4.6590
Next 20,000 gallons	4.4446
Next 30,000 gallons	4.2301
Over 60,000 gallons	3.9085

(b) Minimum Monthly Charge*

Each user shall pay a minimum charge in accordance with the following applicable size of meter installed for which the user will be entitled to the quantity of water set out in the above schedule of rates.
