

ORDINANCE NO. G-02- 15

AN ORDINANCE RESTRICTING WATER USAGE
IN THE TOWN OF GEORGETOWN AND
PROVIDING PENALTIES FOR
VIOLATIONS THEREOF

WHEREAS, the Town Council is the entity responsible for providing minimum standards for the protection of life, limb, health, environment, public safety and general welfare within the Town of Georgetown; and

WHEREAS, residents of the Town of Georgetown have reported problems with inadequate water pressure during normal waking hours to the Town Council; and

WHEREAS, residents of the Town of Georgetown have requested immediate relief while awaiting the completion of the waterworks improvement project undertaken by the Town and currently under construction; and

WHEREAS, after due consideration and discussion it was agreed that the Town Council desires to provide immediate relief to residents of the Town of Georgetown, who have reported difficulties with inadequate water pressure during normal waking hours, and to improve the water services available to residents; and

WHEREAS, after due consideration and discussion it was further agreed that certain restrictions should be enacted on water usage in the Town of Georgetown during normal waking hours, including prohibitions on washing cars, watering lawns, filling swimming pools, and hauling water out of the Town, until the waterworks improvement project can be completed.

NOW, THEREFORE, BE IT ORDAINED that no person within the Town of Georgetown shall use water provided by the Georgetown Water Utility for the purposes of washing cars, watering lawns, and/or filling swimming pools during the hours of 6:00 a.m. through 11:00 p.m.;

NOW THEREFORE BE IT FURTHER ORDAINED that no person within the Town of Georgetown shall remove, transport and/or haul water provided by the Georgetown Water Utility from the Town of Georgetown at any time;

NOW THEREFORE BE IT FURTHER ORDAINED that this Ordinance shall not apply to any commercial business within the Town of Georgetown;

NOW THEREFORE BE IT FURTHER ORDAINED that any person committing a violation of this Ordinance shall be subject to a fine of \$100.00 per violation. Said fine shall be paid to the Clerk-Treasurer of the Town of Georgetown. For any person found to be in continuing violation of this Ordinance, each day during which the person remains in violation of this Ordinance shall constitute a separate offense.

NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall be in effect for a term of one year from the date of its adoption only. This Ordinance shall automatically terminate, and be of no force or effect whatsoever, one year from the date of its adoption by the Town Council of the Town of Georgetown unless renewed by said Council.

NOW, THEREFORE, BE IT FURTHER ORDAINED that any provisions of any Ordinance which are in conflict with this Ordinance are hereby repealed, and that any provisions of any Ordinance which are not in conflict with this Ordinance shall remain in full force and effect.
