

**AN ORDINANCE PROVIDING A SALARY
ADJUSTMENT FOR EMPLOYEES OF
THE TOWN OF GEORGETOWN, INDIANA**

WHEREAS, the Town Council of the Town of Georgetown, Indiana is the entity responsible for establishing the compensation of Town employees pursuant to I.C. 36-5-3-2; and

WHEREAS, the Town Council of the Town of Georgetown has conducted an informal investigation into the salaries paid by similarly situated municipalities in the State of Indiana; and

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown has determined that the salaries paid to employees of the Town of Georgetown are below the average salaries paid by similarly situated municipalities in the State of Indiana; and

WHEREAS, the Town Council of the Town of Georgetown desires to pay the employees of the Town of Georgetown a reasonable, competitive wage; and

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown has determined that a salary adjustment is necessary to provide Town employees with a reasonable, competitive wage.

NOW, THEREFORE, BE IT ORDAINED that the salaries of Town employees shall be adjusted as follows:

1. The salary of the Town Marshal shall be increased by ten percent (10%) to \$707.15 per week.
2. The salary of the First Deputy to the Town Marshal shall be increased by ten (10%) to \$585.28 per week.
3. The salary of the Second Deputy to the Town Marshal shall be increased by ten (10%) to \$568.00 per week.
4. The salary of the Clerk-Treasurer shall be increased by fifteen percent (15%) to \$172.73 per week from the Georgetown General Fund, \$232.09 per week from the Georgetown Water Utility, and \$232.09 per week from the Georgetown Sewer Utility, for a total of \$636.91 per week.
5. The salary of Deputies to the Clerk-Treasurer shall be increased to \$13.50 per hour.


6. The salary of the members of the Town Council, other than the President, shall be increased by five percent (5%) to \$213.92 per month from the Georgetown General Fund, \$93.61 per month from the Georgetown Water Utility, and \$93.61 per month from the Georgetown Sewer Utility, for a total of \$401.14 per month.
7. The salary of the President of the Town Council shall remain unchanged.
8. The salary of the Superintendent shall be increased to \$15.39 per hour.
9. The salary of the Certified Water Operator(s) shall be increased to \$14.00 per hour.
10. The salary of the CDL driver(s) shall be increased to \$12.50 per hour.
11. The salary of all Laborers, except any Sewer Laborer(s), shall be increased to \$10.75 per hour.
12. The salary of the Sewer Laborer(s) shall be increased to \$12.00 per hour.

NOW, THEREFORE, BE IT FURTHER ORDAINED that any provision of any Ordinance of the Town of Georgetown, Indiana that is in conflict with any provision this Ordinance is hereby repealed to the extent of such conflict, and any provision of any Ordinance not in conflict with this Ordinance shall remain in full force and effect.


NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall be effective January 1, 2003.


