

ORDINANCE NO. G-03- 07

**AN ORDINANCE CONCERNING THE PICKUP OF  
EXTRAORDINARY ITEMS OF REFUSE AND GARBAGE  
BY THE TOWN OF GEORGETOWN**

WHEREAS, the Town of Georgetown, Indiana is authorized to furnish and regulate the service of collecting, processing, and disposing of waste substances pursuant to I.C. 36-9-2-16; and

WHEREAS, the Town of Georgetown is authorized to establish the rates and charges for the service of collecting, processing, and disposing of waste substances pursuant to I.C. 36-9-2-16; and

WHEREAS, the Town Council of the Town of Georgetown, after due consideration and discussion, has determined there is a need for pickup of extraordinary items of refuse and garbage within the Town of Georgetown.

NOW THEREFORE BE IT ORDAINED that the Town of Georgetown shall provide pickup of extraordinary items of refuse and garbage, including washers, dryers, stoves and water heaters less 50 gallons or less in capacity, within the Town of Georgetown; and

NOW THEREFORE BE IT FURTHER ORDAINED that there shall be a \$5.00 fee for each extraordinary item of refuse and garbage to be picked up by the Town of Georgetown and that said fee shall be paid in advance of pickup; and

NOW THEREFORE BE IT FURTHER ORDAINED that advance payment for the pickup of extraordinary items of refuse and garbage shall be made at the Georgetown Town Hall; and

NOW THEREFORE BE IT FURTHER ORDAINED that any person who makes an advance payment for pickup of extraordinary items of refuse and garbage shall be issued a sticker for each item to be picked up; and

NOW THEREFORE BE IT FURTHER ORDAINED that no extraordinary item of refuse or garbage shall be picked up by the Town of Georgetown without the appropriate sticker indicating prepayment from the Georgetown Town Hall; and

NOW THEREFORE BE IT FURTHER ORDAINED that the Town of Georgetown will not, under any circumstances, pick up the following items: tires, air conditioning units, refrigerators and/or freezers, as these items require special disposal procedures; and


NOW THEREFORE BE IT FURTHER ORDAINED that any provision of any Ordinance of the Town of Georgetown, Indiana that is in conflict with any provision this Ordinance is hereby repealed to the extent of such conflict, and any provision of any Ordinance not in conflict with this Ordinance shall remain in full force and effect.
