ORDINANCE NO. G-04-01

AN ORDINANCE AMENDING ORDINANCE G-03-18 AN ORDINANCE PROVIDING FOR THE WAGES OF EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Town Council of the Town of Georgetown, Indiana is the entity responsible for establishing the compensation of Town employees pursuant to I.C. 36-5-3-2; and

WHEREAS, the Town Council of the Town of Georgetown, Indiana desires to pay the employees of the Town of Georgetown a reasonable, competitive wage; and

WHEREAS, the Town Council of the Town of Georgetown, Indiana has determined that previously there were two Full-Time Deputy Clerk-Treasurers for the Town of Georgetown, with each receiving \$13.91 per hour under Item Six (6) of Ordinance G-03-18.

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown has determined to Amend Ordinance G-03-18, An Ordinance Providing for the Wages of Employees of the Town of Georgetown, Indiana.

WHEREAS, the Town Council of the Town of Georgetown, Indiana has determined that there will now be one (1) Full-Time Deputy Clerk-Treasurer and two (2) Part-Time Utility Clerk/Office Workers for the Town of Georgetown.

NOW, THEREFORE, BE IT ORDAINED that Ordinance G-03-18, An Ordinance Providing for the Wages of Employees of the Town of Georgetown, Indiana, is amended as follows:

Item Six (6), which previously read:

6. The salary of Deputies to the Clerk-Treasurer shall be increased three percent (3%) to \$13.91 per hour.

is hereby amended to read as follows:

- 6. The Deputy Clerk-Treasurer shall receive an annual salary of \$31,000.00, plus full-time employee benefits.
- 6.1 The two (2) part-time Utility Clerk/Office Workers shall each receive a wage of \$12.00 per hour, up to twenty-four (24) hours per week, with no additional compensation or employee benefits.

NOW, THEREFORE, BE IT FURTHER ORDAINED that any provision of Ordinance G-03-18 of the Town of Georgetown, Indiana that is in conflict with any provision of this Ordinance is hereby repealed to the extent of such conflict, and any provision of Ordinance G-03-18 of the Town of Georgetown, Indiana not in conflict with this Ordinance shall remain in full force and effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED that any provision of any other Ordinance of the Town of Georgetown, Indiana that is in conflict with any provision of this Ordinance is hereby repealed to the extent of such conflict, and any provision of any other Ordinance of the Town of Georgetown, Indiana not in conflict with this Ordinance shall remain in full force and effect.
