

ORDINANCE NO. G-04-09

**AN ORDINANCE NAMING CERTAIN ALLEYS LOCATED
WITHIN THE TOWN OF GEORGETOWN**

WHEREAS, pursuant to I.C. 36-7-4-405, the Georgetown Plan Commission is authorized to recommend street names to the Town Council for adoption; and

WHEREAS, it has recently come to the attention of the Town Council that certain alleys located within the Town of Georgetown are unnamed; and

WHEREAS, the Georgetown Plan Commission determined that in the interest of the public health and safety of the residents of the Town of Georgetown said alleys should be named so that they may be readily located by emergency services personnel; and

WHEREAS, the Georgetown Plan Commission, after due consideration and discussion, determined that said unnamed alleys located within the Town of Georgetown should be named after long-time residents of the Town of Georgetown.

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Georgetown, Indiana, that the previously unnamed alleys, the location of which is depicted on the map attached hereto as Exhibit "A" and incorporated herein by reference, shall be and are hereby named as follows:


Heavenly Way (next to Baptist Church);
Allen Way, named after after Mr. Oral Allen;
Fuzzy Way, named after Mr. Fairly Stinnett;
Fravel Way, named after Mr. Herman Fravel, the oldest living resident of Georgetown;
Hatfield Way, after Ms. Opal Hatfield;
Bailey Way, named after Mr. Ed Bailey;
Chaffin Way, named after Mr. Rex Chaffin;
Lawrence Moore Way, named after Mr. Lawrence Moore, retired principal; and
Lagel Way, named after the Lagel family.

NOW THEREFORE BE IT FURTHER ORDAINED that should any term or provision of this Ordinance be declared to be unconstitutional or invalid by a court of competent jurisdiction, such determination shall not affect the remainder of this Ordinance which shall remain in full force and effect; and


