

ORDINANCE NO. G-04-20

**AN ORDINANCE PROVIDING FOR OVERTIME COMPENSATION
FOR CERTAIN THE EMPLOYEES OF THE TOWN OF GEORGETOWN**

WHEREAS, pursuant to I.C. 36-5-3-2, the Town Council of the Town of Georgetown, Indiana is the entity responsible for establishing the compensation of the officers and employees of the Town of Georgetown; and

WHEREAS, a tornado touched down in the Georgetown, Indiana area on or about May 27, 2004, causing severe damage to numerous homes and businesses, uprooting many large trees and knocking down power lines;

WHEREAS, it is the determination of the Georgetown Town Council that certain Town employees went above and beyond the call of duty in providing their services to the Town during and immediately after the severe weather that struck Georgetown; and

WHEREAS, the Town of Georgetown has been awarded Federal Emergency Management Agency Public Assistance funds to cover the cost of the overtime compensation for said employees; and

WHEREAS, the Georgetown Clerk-Treasurer has received assurances from the Indiana Department of Labor and the Indiana State Board of Accounts that said employees are eligible to receive such overtime compensation; and

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown has determined that certain Georgetown employees should receive overtime compensation for their efforts and assistance provided to the Town in a time of crisis.

NOW THEREFORE BE IT ORDAINED that the following Georgetown employees shall receive overtime compensation as stated below:






