Ordinance # G-04- 43

AN ORDINANCE PROVIDING FOR THE WAGES OF EMPLOYEES OF THE TOWN OF GEORGETOWN AMENDING ORDINANCE NUMBERS G-04-01, G-04-03, G-04-08, G-04-11, & G-03-22

WHEREAS, the Town Council of Georgetown is the entity responsible for establishing the compensation of the Town employees pursuant to IC 36-5-3-2; and,

WHEREAS, the Town Council of the Town of Georgetown desires to pay the employees of the town of Georgetown a reasonable and competitive wage; and,

WHEREAS, the Town's Utilities employees have saved the Town over \$5,000 in the costs of pumping sewage holding tanks over previous years by changes in management policies; and,

WHEREAS, the Town's Utilities employees have replaced seven sewer holding tanks, saving the Town approximately \$15,000; and,

WHEREAS, the Town's Utilities employees have stopped using contractors and are doing a great deal of the Town's own construction-related work; such as building a new bridge on Frank Ott Road, replacing and repairing fire hydrants, renovating the insides of manholes, etc.; and,

WHEREAS, after due consideration and discussion, the Town Council of the Town of Georgetown has determined that the employees listed below shall receive the stated compensation.

NOW THEREFORE, BE IT ORDAINED the positions and salaries of the Town employees shall be set as follows, effective January 1, 2005:

SECTION 1. UTILITIES DEPARTMENT

Water Licenses: Personnel with a State-issued water operator license shall receive a 5% override to their wages, while they are working in the water utility.

Commercial Driver Licenses (CDL): Personnel with a State-issued commercial driver's license shall receive a 5% override to their wages, while they are driving the garbage packer or the tandem-wheeled dump truck.

Heavy Equipment Operation: Personnel with a Town-issued certificate to operate the Town's backhoe shall receive a 5% override to their wages, while they are working as a backhoe operator.

SECTION 4. SEVERABILITY


Should any portion of this ordinance be found to be invalid or unconstitutional, the remaining parts of this ordinance shall be severable and shall continue in full force and effect.

This ordinance shall be in full force and effect January 1st, 2005 and after adoption by the Town Council.






