Ordinance No. G-05-15

**AN ORDINANCE TO FORMALLY ADOPT
AND ACCEPT THE EXTENSION OF MARTIN
DRIVE IN AND FOR THE TOWN OF
GEORGETOWN, IN.**

WHEREAS, the Town Council has accepted the public dedication of the northern extension of Martin Drive which has been private property in the Town of Georgetown for many years; and,

WHEREAS, Ms. Eva Andres and Prospect Street Properties, LLC, citizens of the Town of Georgetown, Indiana, have petitioned the Town and offered to dedicate the land identified by the legal description below to the public good.

NOW, THEREFORE, BE IT ORDAINED BY THE **GEORGETOWN TOWN COUNCIL**

Section 1. The property described below is hereby accepted and dedicated to the public's use as the northern extension of **Martin Drive**.

A part of the Northeast Quarter of Section 32, Township 2 South, Range 5 East, Floyd County, Indiana and being a part of Plat 501, and being more particularly described as follows: Beginning at an iron pin in the center of Martin Drive (ten [10] feet wide), said iron pin marking the Northeast corner of Plat 407 and the Northwest corner of Plat 498, and running thence South 89°, 49', 47" East along the North line of Plat 498 for a distance of ten [10] feet; thence running north 00°, 50', 11" west for a distance of 200 feet to a point in the North line of Plat 407 and the Western line of Martin Drive, thence running South 89°, 49', 47" East along the Northern line of Plat 407 for a distance of ten [10] feet to the place of beginning and being a ten [10] foot by 200 foot extension of Martin Drive.

This is a "new road" for reporting purposes to the State Department of Transportation.

Section 2. Any portion(s) of previously enacted ordinances that conflict with this ordinance are hereby repealed.

Section 3. Severability - Should any portion of this ordinance or the referenced Personnel Policies be found to be invalid or unconstitutional, the remaining parts of this ordinance shall be severable and shall continue in full force and effect.

This ordinance shall be in full force and effect as of the date of adoption by the Town Council.
