Ordinance # G-06- 02

AN ORDINANCE AMENDING §71.04 OF THE GEORGETOWN CODE OF ORDINANCES, TO PROHIBIT PARKING IN, ABOVE, AND AROUND PUBLIC UTILITIES FACILITIES IN THE TOWN OF GEORGETOWN

BE IT ORDAINED BY THE
TOWN COUNCIL OF THE TOWN OF GEORGETOWN,
INDIANA THAT:

WHEREAS, the Town Council of Georgetown has reviewed Ordinance Number G-94-15 and its codification as §71.04 of the new Code of Ordinances; and,

WHEREAS, the Town Council of Georgetown has identified that the parameters set forth by G-94-15 are proper, but these policies need to be expanded for the good of the Town and the long-term safety of our citizens; and,

WHEREAS, there have been several occasions when the public utilities personnel cannot access public utilities facilities due to the fact that those facilities are being obstructed by the parking of a vehicle within the only available path to access these publicly owned facilities.

NOW THEREFORE, BE IT ORDAINED:

SECTION 1. Section 71.04 of the Code of Ordinances is hereby amended to read:

§ 71.04 DISTANCE FROM HYDRANT, A PUBLIC UTILITY FACILITY

No parking on any street, or access road, or path, or public parking lot shall be permitted within 20 feet of any public utility facility, to include but not limited to a fire hydrant, a fire station, a lift station, a booster station, a pressure relief valve, a water main valve, a water meter pit, a drainage catch basin, etc.

SECTION 2. The penalty for violation of this ordinance continues to be as stated in Section 71.99 of the Code of Ordinances.

§ 71.99 PENALTY.

(A) Any person who violates any provision of this chapter for which no penalty is provided shall be subject to the terms of § 10.99.

(B) Whoever violates any provision of §§ 71.02 through 71.05 shall be fined a sum not less than \$10 nor more than \$100 for each offense. (Ord. G-94-15, passed 7-18-1994)


Adding a new paragraph C.

(C) In the event of an emergency, as determined by the Town Marshal or his duly appointed representative, a vehicle parked in a "No Parking" area may be towed, at the owner's expense.


SECTION 3. The remainder of Section 71 of the Code of Ordinances is confirmed and reiterated.

NOW, THEREFORE, BE IT FURTHER ORDAINED that all Ordinances of the Town of Georgetown, Indiana which are in conflict with this Ordinance are hereby repealed to the extent of such conflict, and any Ordinance not in conflict with this Ordinance shall remain in full force and effect.




