Ordinance # G-06- 08

AN ORDINANCE CREATING CHAPTER 74 OF THE GEORGETOWN CODE OF ORDINANCES, PROHIBITING CONSTRUCTION TRAFFIC TO TRAVEL ON OAKSTONE WAY, IN THE BROOKSTONE SUBDIVISION IN THE TOWN OF GEORGETOWN

**BE IT ORDAINED BY THE
TOWN COUNCIL OF THE TOWN OF GEORGETOWN,
INDIANA THAT:**

WHEREAS, the Town Council of Georgetown has reviewed the Code of Ordinances in follow up to several months of discussion about providing school bus pick-up service in Phase 2 of the Brookstone subdivision; and,

WHEREAS, the Town Council continues to believe that although Phase 2 of Brookstone is not yet complete, it is in the best interest of our citizens, and particularly our citizens of school attendance age, that they be picked up near their house, as opposed to picking them up at the subdivision entrance; and,

WHEREAS, the Town Council has determined that the opening of Oakstone Way to all except construction traffic is a practical compromise to facilitate the New Albany-Floyd County School Corporation's Transportation Department picking up school children at routine stops within the residential area of Phase 2 of Brookstone.

NOW THEREFORE, BE IT ORDAINED:

SECTION 1. Section 74.01 of the Code of Ordinances is hereby created.

§ 74.01 TRAVEL ON OAKSTONE WAY

The Office of the Georgetown Marshal is hereby authorized and directed to monitor traffic on Oakstone Way in the Brookstone subdivision. Any construction traffic operating on Oakstone Way may be cited and fined in accordance with §74.99.

(A) Construction Traffic defined: Any vehicle being operated by a contractor, sub-contractor, or an employee of either, working in the Brookstone subdivision to build, construct, or install facilities and equipment incidental to the construction of a single family residence.

SECTION 2. Section 74.99 of the Code of Ordinances is hereby created.

§ 74.99 PENALTY

Any person, firm, or corporation who violates any provision of Chapter 74 shall, upon conviction, be subject to a fine not exceeding \$100. A separate offense shall be deemed committed upon each day during which a violation occurs or continues.


Power to prescribe fines up to \$2,500 granted, see I.C. 36-1-3-8(a)(10) and successor statutes that may be enacted

SECTION 3. The remainder of Title VII, TRAFFIC CODE, of the Code of Ordinances is confirmed and reiterated.

SECTION 4. This Ordinance shall be repealed by the Georgetown Town Council when the Brookstone subdivision is developed to the point that construction traffic is no longer traveling in the subdivision on a daily basis.

NOW, THEREFORE, BE IT FURTHER ORDAINED that all Ordinances of the Town of Georgetown, Indiana which are in conflict with this Ordinance are hereby repealed to the extent of such conflict, and any Ordinance not in conflict with this Ordinance shall remain in full force and effect.






