Ordinance # G-07-12

## **AN ORDINANCE AMENDING ORDINANCE G-05-23 CREATING A BROADBAND UTILITY OPERATOR EMPLOYEE POSITION FOR THE TOWN OF GEORGETOWN**

BE IT ORDAINED BY THE TOWN COUNCIL  
OF THE TOWN OF GEORGETOWN, INDIANA:

**WHEREAS**, the Town Council has created a Broadband Utility Fund from which to operate the new Broadband Utility Enterprise; and,

**WHEREAS**, the creation of this new utility will require additional manpower to operate the utility; and,

**WHEREAS**, the Town of Georgetown already has an established practice of having at least one man as an expert in each of the utility services we provide to the Town and then relying on extensive cross-training and teamwork to properly and efficiently deliver that utility to our citizens; and,

**WHEREAS**, the contract has been signed with Discernity, LLC, a highspeed internet vendor and they have decided that the Town must employ our own Information Technology Expert to operate **mygwhiz.org**, the Town's Wireless Broadband Utility.

NOW THEREFORE, BE IT ORDAINED:

**SECTION 1.** Section 4 of Ordinance G-05-23 is hereby amended to allow for an additional Utility Operator position as the Town's Broadband Operator. This new Broadband Utility Operator will be paid at the same rate/wage as the existing Utility Operator position, in accordance with the overall structure of the Omnibus Merit Wage Increase Ordinance (G-05-23). This will provide for a Water Utility Operator and a Broadband Utility Operator in total at this time. This means the Town Manager will hire existing Contractor Jon Gerry to the Broadband Operator position.

### **SECTION 2. SEVERABILITY**

Should any portion of this ordinance be found to be invalid or unconstitutional, the remaining parts of this ordinance shall be severable and shall continue in full force and effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED that all Ordinances of the Town of Georgetown, Indiana which are in conflict with this Ordinance are hereby repealed to the extent of such conflict, and any Ordinance not in conflict with this Ordinance shall remain in full force and effect.
