TOWN OF GEORGETOWN, IN Ordinance No. G-07-29

AN ORDINANCE AMENDING ORDINANCE G-04-17 CONCERNING RATES FOR GARBAGE COLLECTION BY THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Town Council for the Town of Georgetown, Indiana, in the interest of public health and safety, has deemed it necessary that the Town develop, update and maintain laws which regulate the accumulation and disposal of trash, rubbish and other waste materials; and,

WHEREAS, the Town Clerk-Treasurer and his staff have identified to the Town Council that rates adopted three years ago by Ordinance G-04-17 no longer adequately provide for the costs the Town is incurring to make weekly garbage pick-ups, weekly recycling collection, monthly brush collection and semi-annual junk collection; and,

WHEREAS, the Sanitation Fund has lost an average of \$4,698 per month for the first seven months of 2007; and,

WHEREAS, by State Law the Sanitation enterprise Fund must break even, it is the Town Council's responsibility, at the recommendation of the Town Clerk-Treasurer to increase the Town's rates for the collection of garbage in and for the Georgetown Sanitation Division of the Public Utilities Department.

NOW, THEREFORE, BE IT ORDAINED BY THE GEORGETOWN TOWN COUNCIL

Section 1. Confirmation and Reiteration.

Sections 8 of Ordinance G-04-17, also identified as Section 51.21 of the Town's Code of Ordinances is hereby amended as shown.

Section 8. Fees

For the once weekly, curbside garbage collection, once weekly recycling collection, once monthly (in season) yard waste/brush collection, and twice annual Junk Day, the single family residential garbage collection fee for in-town residences is: \$11.00 15.00 per month. [Internal Accounting Directive: Two dollars (\$2) of this fee shall be used to offset Recycling expenses. The remaining nine dollars (\$9) shall be used to offset all other garbage collection expenses within the Sanitation Utility Fund.]

For in-town multi-family residences, the collection fee shall be \$15.00 for the first unit, and \$12.00 for each additional unit, if billing is in accordance with the multi-family building rate.

For out of town residential collection the fee shall be \$18.00 per month.

For out of town multi-family residences, the collection fee shall be \$18.00 for the first unit, and \$15.00 for each additional unit, if billing is in accordance with the multi-family building rate.

For once weekly, curbside garbage collection, once monthly (in season) yard waste/brush collection, and twice annual Junk Day, the **commercial** garbage collection fee is: \$20.00 and per month.

For out of town commercial collection the fee shall be \$36.00 per month.

Section 2. Any portion(s) of previously enacted ordinances that conflict with this ordinance are hereby repealed.

Section 3. Severability - Should any portion of this ordinance be found to be invalid or unconstitutional, the remaining parts of this ordinance shall be severable and shall continue in full force and effect.

This ordinance shall be in full force and effect October 1st, 2007.

Introduced for first reading on August 16, 2007.
