

Ordinance No. G-98- 10

ORDINANCE AMENDING ORDINANCE NO. G-95-10 REZONING
A PORTION OF AN "R- 2 RESIDENTIAL" DISTRICT TO A
"COMMERCIAL GENERAL" DISTRICT.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF
GEORGETOWN, INDIANA THAT:

WHEREAS, the Town Council of the Town of Georgetown is empowered pursuant
to the provisions of I.C. 36-7-4-602 to change Zone Maps; and

WHEREAS, the Planning Commission has initiated a proposal to change the Zone
Maps for the Town of Georgetown, Indiana; and

WHEREAS, the Town Council is desirous of adopting by this Ordinance an
updated Zone Map to change zoning classifications for the geographic area beginning at
the intersection of Georgetown-Lanesville Road and State Road 64, from 9225 State
Road 64 West to the bridge located on the East side of 9375 State Road 64 West, the
South border being Georgetown Creek. The aforementioned residential property in this
geographic area shall be rezoned to "Commercial General" property; and

WHEREAS, the proposed change to Zone Maps found herein shall be incorporated
by reference to the existing Zoning Ordinance for the Town of Georgetown, Indiana.

NOW THEREFORE BE IT ORDAINED that the Zone Maps for the Town of
Georgetown shall be altered to change zoning classifications for the geographic area
beginning at the intersection of Georgetown-Lanesville Road and State Road 64 from
9225 State Road 64 West to the bridge located on the East side of 9375 State Road 64
West, the South border being Georgetown Creek. The aforementioned residential
property in this geographic area shall be rezoned to "Commercial General"


property. Such change to the Zone Maps shall hereby be incorporated to the existing Zone Ordinance for the Town of Georgetown, Indiana.



This Ordinance shall be effective May 26, 1998.


