\$ 8.35 per hour

2nd Assistant Utility Clerk

\$ 8.00 per hour

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the following Town employee shall receive the following salary so long as there is no appointed or elected Clerk/Treasurer in office;

Barbara Zoller

\$449.60 weekly for an annual salary of \$23,279.20

NOW, THEREFORE, BE IT FURTHER RESOLVED, that if a Clerk/Treasurer is appointed, elected or takes office, then the Town Council shall have the option of changing the amount and/or structure of Barbara Zoller's compensation at that time.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Water Utility, the Sewer Department and the Town of Georgetown shall each be responsible, to the extent allowed by law, for a portion of the compensation paid to said employees, with each entity's proportionate share to be determined by the Clerk/Treasurer with the Town Council's approval.
