

**ORDINANCE ESTABLISHING RATES FOR SOLID  
WASTE MANAGEMENT AND RECYCLING**

BE IT ORDAINED BY THE TOWN COUNCIL OF GEORGETOWN, INDIANA

THAT:

WHEREAS, the Town Council is the entity responsible for collection, disposal and recycling of solid waste for the Town of Georgetown;

WHEREAS, the Town of Georgetown desires to implement and administer a curbside collection and recycling program for the solid waste produced by the residents of the Town of Georgetown for a fee of one dollar (\$1.00) per participating household per month;

WHEREAS, the Town Council of the Town of Georgetown desires to enter into an Interlocal Agreement with the Floyd County, Indiana Solid Waste Management District whereby said District shall contribute to the program sixty cents (\$.60) per participating household per month, but not to exceed the sum of six thousand dollars (\$6,000.00) during any twelve month period; and

WHEREAS, the Town of Georgetown desires to contract with Rumpke of Indiana, Inc. for services enumerated in the contract and addendum previously entered into by and between Rumpke and Floyd County, Indiana Solid Waste Management District, attached hereto as Exhibit "A."

NOW THEREFORE BE IT ORDAINED that the Town of Georgetown shall design, implement and administer a program for curbside collection and recycling of solid waste generated by the residents of the Town of Georgetown for a fee of one dollar (\$1.00) per participating household per month;

NOW THEREFORE BE IT FURTHER ORDAINED that the Town of Georgetown shall enter into an Interlocal Agreement with the Floyd County, Indiana Solid Waste Management District whereby said District shall contribute to the program sixty cents (\$.60) per participating-household per month, but not to exceed the sum of six thousand dollars (\$6,000.00) during any twelve month period;

NOW THEREFORE BE IT FURTHER ORDAINED that the Town of Georgetown shall contract with Rumpke of Indiana, Inc. for services enumerated in the contract previously entered into by and between Rumpke and Floyd County, Indiana Solid Waste Management District, attached hereto as Exhibit "A"; and


