

ORDINANCE NO. G-99- /C

**AN ORDINANCE FOR THE APPOINTMENT OF RESERVE DEPUTY MARSHAL'S TO THE MARSHAL'S DEPARTMENT AND FOR MANDATED TRAINING REQUIREMENTS.**

WHEREAS, the Town of Georgetown Marshal's Department has used reserve deputies in the past to supplement the Marshal's Department in terms of manpower to adequately protect the health, safety, and well being of the inhabitants of it's town and

WHEREAS, the Town Council of Georgetown, Indiana wishes to conform to Indiana state statues pertaining to the appointment and training of reserve deputies now find it desirable to establish a limited number of reserve deputies positions and do HEREBY authorize the Town Marshal to fill these positions as per IC 36-8-3-20.

WHEREAS, the Town Council wishing to conform with Indiana statue does now HEREBY order the Town Marshal to conform all training of reserve deputies to IC 4-22-2 (pre-basic) mandated training and completion of 40hrs of pre-service training prior to any participation in departmental training, and as per Indiana Code IC 36-8-3-20 which requires a reserve officer to complete the agencies training and probationary period as per department rules before he can be appointed as a reserve officer.

A reserve trainee may be appointed as a special deputy during his training period, to allow for the carrying of a firearm during his training period. It is understood that a special deputy appointment is only for the reserve officers training period and during this time he or she will have NO powers of arrest while off duty and will only have powers of arrest when in the company of a certified Georgetown Deputy or the Town Marshal.

Now, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Georgetown, Floyd County, Indiana, that:

**SECTION 1.** There is hereby established the office of reserve deputy to be appointed by the Town Marshal and to serve under the Town Marshal. Reserve deputies serve at the pleasure of the Town Marshal and must be reappointed if there is a change in the office of the Town Marshal.

**SECTION 2.** Any person that makes an application for appointment as a reserve deputy shall have a background investigation done. This background investigation shall consist of a NCIC/IDACS check, local criminal history check, local warrant check of surrounding counties, and any out of state location at which the applicant may have resided for any period of time. A FBI fingerprint card shall be filled out and forwarded to the Indiana State Police for a fingerprint file search. An investigation shall be conducted of the applicants driving history and kept on file.

A file shall be kept on each reserve officer appointee to attest his or her background investigation was completed.

**SECTION 3.** The number of reserve deputies shall be limited to ten (10)

**SECTION 4.** Reserve deputies shall serve without remuneration of any type.

**SECTION 5.** Reserve deputies shall be added to the department's liability insurance plan, when they are appointed as special deputies after pre-basic. The Marshal shall keep the Town's insurance carrier informed as to number of reserve (specials) officers and supply them with any information that they may require, such as driving history, name, address.

**SECTION 6.** Reserve officers shall be required to participate in a continuing education program after completing basic department training.

**SECTION 7.** Each reserve officer applicant shall be required to have a physical examination prior to participation in any department training. Such physical examination shall be placed in reserve officer's file.(At his or her expense)

**SECTION 8.** Each reserve officer shall be required to perform a physical agility test before appointment.

**SECTION 9.** All other ordinances or resolutions, or parts of ordinances or resolutions, in conflict herewith are hereby repealed. The invalidity of each section, clause, sentence, or provision of this ordinance shall not affect the validity of any other part of this ordinance, which can be given effect without such invalid part or parts.

**SECTION 10.** This ordinance shall be in full force and effect from and after its passage,

**SECTION 11.** Nothing in this ordinance shall prevent the Marshal from appointing as many SPECIAL deputies as needed in a time of crisis under IC 36-5-7-4 (4) calling the town to his aid. (specific purpose , short term).
