**RESOLUTION OF TOWN COUNCIL

Resolution To Accept The Land Appraisal And Review Of Land Appraisal To Be Utilized In The Waterworks Improvements Project Of Georgetown, Indiana

WHEREAS, the Town Council for the Town of Georgetown, Indiana, is the entity responsible to accept or reject the Appraisal conducted by Donald E. McCartin for the property located at 583 Baylor-Wissman Road, Georgetown, Indiana and owned by William J. and Geneva M. Emmons, dated September 12, 2000, to be utilized in the Waterworks Improvements Project of Georgetown, Indiana; and

WHEREAS, the Town Council for the Town of Georgetown, Indiana, is the entity responsible to accept or reject the Review of Donald E. McCartin's September 12, 2000 Appraisal conducted by Warren V. Nash Appraisals, whereby Warren V. Nash Appraisals independently inspected said property and reported that Donald E. McCartin's Appraisal was prepared with true and correct facts and data and in conformity with the Uniform Standards of Professional Appraisal Practice; and

WHEREAS, the Town Council for the Town of Georgetown, Indiana, is the entity responsible to accept or reject that the Appraisal and Review Appraisal as conducted and reviewed truly and accurately; and

WHEREAS, the Town Council for the Town of Georgetown, Indiana, intends to acquire this property for the Waterworks Improvements Project of Georgetown, Indiana subject to appropriate grant and/or possible loan financing; and

WHEREAS, the adoption of this Resolution is necessary and a pre-condition to receipt by the Town of funds distributed by the Indiana Department of Environmental Management and the federal government.

McCartin, as well as the independent Review of the Appraisal conducted by Warren V.
