**RESOLUTION OF TOWN COUNCIL
OF GEORGETOWN, INDIANA**

Resolution to Dedicate Payne Drive as a Public Right of Way
by the Town of Georgetown, Indiana

WHEREAS, the Town Council of Georgetown, Indiana, is the entity responsible for dedicating roadways as a public right-of-way within the Town of Georgetown, Indiana;

WHEREAS, the Town Council takes into account the arrangement, character, extent, width, grade and location of all streets in relation to existing and planned streets, traffic conditions, topographical conditions, and public convenience and safety in its decision to dedicate roadways as a public right-of-way;

WHEREAS, the Town asserts jurisdiction over dedicated public right-of-ways for purposes of implementing and enforcement of speed limits, road signs, road maintenance and any and all other issues related to public safety;

WHEREAS, the Town desires to dedicate Payne Drive, described in Plat No. 1104, which is a replatting of Plat No. 1100, as a public right-of-way within the Town of Georgetown;


