Resolution # R-06- 11

A RESOLUTION OF THE TOWN COUNCIL OF GEORGETOWN CREATING NEW BUDGETARY LINE ITEMS IN THE GENERAL, WATER OPERATING AND SEWER OPERATING FUNDS IN ACCORDANCE WITH DIRECTIONS FROM THE STATE BOARD OF ACCOUNTS

WHEREAS, the Town Council for the Town of Georgetown, Indiana is the entity responsible to appropriate and otherwise direct the use of the monies of Georgetown, and the Town of Georgetown is a Town chartered in and by the State of Indiana; and,

WHEREAS, the Town Council for the Town of Georgetown, Indiana is the local governing board, in accordance with Indiana State Law; and,

WHEREAS, the State Board of Accounts has informed the Clerk-Treasurer and the Town Council that certain expenditures made to recognize longevity of service of Town employees as well as those costs associated with promoting the Town and hosting business meetings shall be charged against a "Promotions" line item in the budgets, which at this time does not exist, and;

WHEREAS, the Town Council believes it is in the best interest of the Town's citizens to properly fund these promotional expenses by creating the required line items..

NOW THEREFORE, BE IT RESOLVED by the
Town Council for the Town of Georgetown as follows:

SECTION 1. General Fund, #101

Expenses:

A new line item entitled "Promotions" is hereby created for the FY 2006 (current) Budget, and shall remain a valid line item unless deleted by a similar act of the Town Council. Since it is being created in mid-year, there is no amount of money budgeted for this line item, but expenses will be charged against the new line item such that the Town can incrementally establish the proper funding for this line item in future budgets.

SECTION 2. Water Operating Fund, #601

Expenses:

A new line item entitled "Promotions" is hereby created for the FY 2006 (current) Budget, and shall remain a valid line item unless deleted by a similar act of the Town Council. Since it is being created in mid-year, there is no amount of money budgeted for this line item, but expenses will be charged against the new line item such that the Town can incrementally establish the proper funding for this line item in future budgets.

SECTION 3. Sewer Operating Fund, #606


Expenses:

A new line item entitled "Promotions" is hereby created for the FY 2006 (current) Budget, and shall remain a valid line item unless deleted by a similar act of the Town

Council. Since it is being created in mid-year, there is no amount of money budgeted for this line item, but expenses will be charged against the new line item such that the Town can incrementally establish the proper funding for this line item in future budgets.

This ordinance shall be in full force upon adoption by the Town Council.






