

**TOWN OF GEORGETOWN, INDIANA
ORDINANCE NO. G-19-02**

**AN ORDINANCE FIXING SALARIES AND WAGES OF OFFICERS AND
EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA FOR CALENDAR YEAR 2020.**

WHEREAS, pursuant to Indiana Code 36-5-3-2, the town legislative body wishes to set the salaries and wages for officers and employees of the Town for calendar year 2020.

NOW THEREFORE, be it ordained by the Town Council of Georgetown, Indiana:

SECTION I –EMPLOYEES WAGES/SALARIES

That, from after the first day of January, 2020, the current employees, and the Clerk Treasurer, of the Town of Georgetown, Indiana as of January 1, 2020 shall receive the wages/salary listed below on the column to the right of their position. The wages/salaries listed below includes the 3% cost of living increase for which the Town Council is approving for the calendar year 2020. Said cost of living increase only applies to Town employees, and Clerk Treasurer, and shall not apply to all other elected officials.

SECTION II – APPOINTED OFFICIALS

Members of the Plan Commission, Board of Zoning Appeals and Storm Water Board shall receive a stipend of \$60 per meeting attended.

Notes:

1. Members of the Town Council are not entitled to received additional compensation for service on boards or commissions.

SECTION III – MISCELLANEOUS

All prior ordinances not in direct conflict, including the prior ordinance, Ordinance G-15-26, Section II, related to hire in rates for new employees shall not be affected by this ordinance.




