Gary Smith made a motion to adjourn the meeting. Seconded by Chris Loop and approved 5-0.

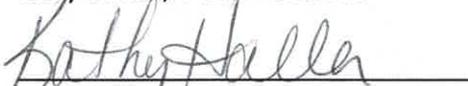

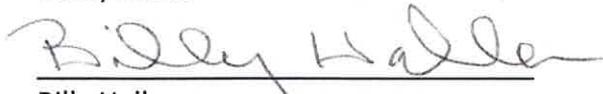

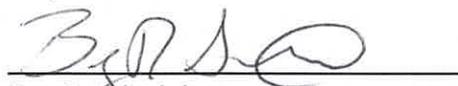
