Pledge of Allegiance

Roll Call

Council members present: Everett Pullen, Josh Williams, Chris Loop, Kathy Haller, and Gary Smith. Also in attendance: Bob Woosley, Chief Denny Kunkel, Steve Broadus, and Brenton Fender.

President

Kathy Haller made a motion to elect Josh Williams as Town Council President. Seconded by Josh Williams. The motion failed by a vote of 2-3. Gary Smith, Chris Loop, and Everett Pullen voted "no."

Gary Smith made a motion to elect Everett Pullen as Town Council President. Seconded by Chris Loop and approved 3-2. Kathy Haller and Josh Williams voted "no."

Vice President

Kathy Haller made a motion to elect Josh Williams as Town Council Vice President. The motion died due to a lack of a second.

Gary Smith made a motion to elect Chris Loop as Town Council Vice President. Seconded by Josh Williams and approved 4-1. Kathy Haller voted "no."

Town Engineer

Kathy Haller made a motion to retain Bob Woosley as Town Engineer. Seconded by Chris Loop and approved 5-0.

Town Marshal

Chris Loop made a motion to retain Denny Kunkel as Town Marshal. Seconded by Gary Smith and approved 5-0.

Town Attorney

Gary Smith made a motion to retain Kristi Fox as Town Attorney. Seconded by Kathy Haller and approved 5-0.

Josh Williams made a motion to approve and allow Everett Pullen to sign Kristi Fox's contract. Seconded by Chris Loop and approved 5-0.

Building Inspector and Commissioner

Kathy Haller made a motion to terminate Steve Broadus from his duties as Building Inspector and Commissioner. Seconded by Josh Williams and approved 5-0.

Josh Williams made a motion to hire Ronnie Glotzbach as a temporary contract worker to fill in as Building Inspector and Commissioner. Seconded by Kathy Haller and approved 5-0.

Chris Loop made a motion to allow Kristi Fox and Everett Pullen to discuss employment with Ronnie Glotzbach out of the meeting and allow the signing of an employment contract. Motion died for the lack of a seconded.

Josh Williams made a motion to rescind the motion hiring Ronnie Glotzbach as a contract employee. Seconded by Chris Loop and approved 5-0.

Chris Loop made a motion to hire Ronnie Glotzbach as temporary Building Inspector and Commissioner under current ordinances, with the understanding that the town will immediately seek his permanent replacement. Seconded by Gary Smith and approved 5-0.

BZA

Kathy Haller made a motion to reappoint Michael Mercer to the BZA for 4 years. Seconded by Chris Loop and approved 5-0.

Safety Panel

Chris Loop made a motion to retain Denny Kunkel, Kathy Haller, and Julia Keibler on the Safety Panel. Seconded by Gary Smith and approved 5-0.

Adjournment

Chris Loop made a motion adjourn. The motion died for lack of a second.

Town Bank

Kathy Haller made a motion to retain Mainsource Bank as the Town Bank. Seconded by Gary Smith and approved 5-0.

River Hills Economic Development Committee Representative

Kathy Haller made a motion to appoint Brenton Fender as the Town's representative to the River Hills Economic Development Committee. Seconded by Chris Loop and approved 5-0.
