A Resolution for Sale of Personal Property

WHEREAS, the town legislative body is the entity responsible for sale of Town personal property.

WHEREAS, Indiana Code 5-22-22-3 allows for the sale of property belonging to a governmental body, which is no longer needed or is unfit for the purpose for which it was intended.

WHEREAS, Indiana Code 5-22-22-6 allows for the sale of property belonging to a governmental body, by public or private sale or transfer without advertising; and

WHEREAS, the Town Council desires to sell some items which are no longer needed or are now unfit for the purpose which they were intended, as defined in the attached Exhibit A; and

WHEREAS, the Town wishes to move forward with the sale by private party.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA:

- 1) The Georgetown Town Council hereby wishes to sell the items identified in the attached Exhibit A by private party.
- 2) The Georgetown Town Council previously agreed to dispose of the items in Exhibit A, but has determined that some items have some value.
- 3) The Georgetown Town Council now removes the items in Exhibit A from the prior Resolution R-20- directing disposal. Said items on Exhibit A shall now be sold pursuant to this Resolution.
- 4) The Georgetown Town Council hereby directs the Clerk's Office coordinate the receipt of funds directly from the purchaser for the sale of the item.
- 5) The Georgetown Town Council hereby directs that the items in Exhibit A shall be sold for \$200.00.
- 6) The proceeds from the sale shall be placed in the Police Continuing Education fund.
