A Resolution for Transfer of Personal Property

WHEREAS, the town legislative body is the entity responsible for sale of Town personal property.

WHEREAS, Indiana Code 5-22-22-3 allows for the sale of surplus property belonging to a governmental body, which is no longer needed or is unfit for the purpose for which it was intended.

WHEREAS, Indiana Code 5-22-22-6 allows for the sale of property belonging to a governmental body, by public or private sale or transfer without advertising; and

WHEREAS, Indiana Code 5-22-22-10 allows for the transfer of property between governmental bodies; and

WHEREAS, the Town Council desires to transfer some items which are no longer needed or are now unfit for the purpose which they were intended; and

WHEREAS, the Town wishes to move forward with the transfer of this property by transfer to other governmental bodies; and

WHEREAS, Indiana Code 5-22-2-13 defines those bodies which are governmental in the State of Indiana; and.

WHEREAS, the Indiana Law Enforcement Academy is a governmental body; and


WHEREAS, the Prosser School in New Albany, Indiana is a governmental body.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA:

- 1) The Georgetown Town Council hereby wishes and agrees to transfer a 2004 Crown Vic (VIN: 2FAFP71W64X154940), with an approximate value of \$1,000.00 or less, to the Indiana Law Enforcement Academy in exchange for Credit Hours for the Georgetown Police Department with the STOPS program.
- 2) The Georgetown Town Council hereby wishes and agrees to transfer a 2003 Crown Vic (VIN: 2FAFP71W93X126984), with an approximate value of \$1,000.00 or less, to Prosser School in New Albany, Indiana, specifically the Law Enforcement Program.
- 3) The Georgetown Town Council hereby directs the Clerk's Office coordinate the transfer of the above items as outlined herein.



WHEREAS, Indiana Code 5-22-22-10 allows for the transfer of property between governmental bodies; and

WHEREAS, the Georgetown Town Council desires to transfer to the School Corporation's Prosser Career Education Center, certain property, specifically, a 2003 Crown Vic (VIN: 2FAFP71W93X126984), that is no longer needed or is now unfit for the purpose which it was originally intended for the Town; and

WHEREAS, the Georgetown Town Council passed a resolution to move forward with the transfer of said vehicle to another governmental body; and

WHEREAS, the Board of Trustees for the School Corporation desires to accept the transfer of said vehicle for use in the Prosser Career Education Center's Law Enforcement Program; and
