# TOWN OF GEORGETOWN, INDIANA ORDINANCE NO. G-21-

## AN ORDINANCE FIXING SALARIES AND WAGES OF OFFICERS AND EMPLOYEES OF THE TOWN OF GEORGETOWN, INDIANA FOR CALENDAR YEAR 2022.

**WHEREAS**, pursuant to Indiana Code 36-5-3-2, the town legislative body has the authority and wishes to set the salaries and wages for elected officials and employees of the Town for calendar year 2022.

NOW THEREFORE, be it ordained by the Town Council of Georgetown, Indiana:

#### SECTION I -EMPLOYEES WAGES/SALARIES

That, from after the first day of January, 2022, the current employees of the Town of Georgetown, Indiana as of January 1, 2022 shall receive the wages/salary listed below on the column to the right of their position. The wages/salaries listed below includes the 5% cost of living increase for which the Town Council is approving for the calendar year 2022.

#### SECTION II - APPOINTED OFFICIALS (BOARDS/COMMISSIONS)

All employees and the Clerk Treasurer of the Town of Georgetown, Indiana receive health insurance, vision insurance, dental insurance, life insurance, short term disability, long term disability, and a deferred compensation match.

All Town Council members receive life insurance.

### SECTION IV - MISCELLANEOUS

All prior ordinances not in direct conflict, including Ordinance G-15-26, Section II, related to hire in rates for new employees shall not be affected by this Ordinance.
