RESOLUTION NO. R-22-12

A Resolution Awarding a Contract for the Collection of Solid Waste within the Town of Georgetown, Indiana

WHEREAS, the Town Council for the Town of Georgetown, Indiana has the power to solicit proposals for the consideration, selection, and award of a Contract for Solid Waste Collection (Trash Services) within the Town pursuant to Indiana Code 36-9-30-5.3; and

WHEREAS, the Town of Georgetown conducted a Request for Proposal process for the consideration, selection, and award of a Contract for Solid Waste Collection within the Town; and

WHEREAS, two proposers submitted Proposals to the Town for consideration in the selection and awarding of a Contract for Solid Waste Collection within the Town; and

WHEREAS, the Town Council has reviewed and evaluated the two proposals: and

WHEREAS, the Town Council has determined that the proposal from Sweetland LTD, Inc. meets the municipality's needs and is in the public interest as a result of the below factors evaluated by the Town:

- 1. Overall cost of the contract;
- 2. System reliability;
- 3. Energy efficiency;
- 4. Financial condition of the proposer;
- 5. Compatibility with source separation;
- 6. Recycling systems; and
- 7. Environmental protection.

WHEREAS, the Town Council wishes to proceed with the award of a Contract for Solid Waste Collection for the Town of Georgetown, Indiana.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GEORGETOWN, INDIANA:

- The Georgetown Town Council hereby authorizes the award and execution of a Contract for Solid Waste Collection for the Town of Georgetown, Indiana to Sweetland LTD, Inc.
- 2. The Town Council has determined that this Contract meets the municipality's needs and is in the public interest of the Town of Georgetown and its citizens.
- 3. The Town Council considered the following criteria in selecting a Proposal for Solid Waste Collection:
 - a. Overall cost of the contract;

- b. System reliability;
- c. Energy efficiency;
- d. Financial condition of the proposer;
- e. Compatibility with source separation;
- f. Recycling systems; and
- g. Environmental protection.
- 4. The Town Council hereby authorizes the Town Council President to sign and execute any and all documents necessary to award and enter a contract with Sweetland LTD, Inc. for Solid Waste Collection Services.
