## Brookstone Final Plat Approval – Section 4

All of the curb and gutters are in, as well as, the storm, sewer and water systems. Electric is going in now, this week and next week. Everything is in order and has been reviewed and meets our standards.

Bob Woosley recommends adoption by the Plan Commission. What will happen if you choose to adopt it, you will sign the plat and Jason Copperwaite will take it and have it recorded.

There have not been any erosion or flood control problems. There were questions initially when there was clearing of the property line locations but the developer met with folks and there were some corrections made. There were some encroachments but things were moved.

The mailbox section will be may be going up near the front. Ken Witten said they will be meeting with the post office. As you are pulling in, it would be on the right side. The post office will dictate where it will go. There will be one cluster box.

A binder coat will probably go down in March or April.

Doug Wacker made a motion to approve Brookstone Section 4 Final Plat. Seconded by Chris Loop and approved 6-0.

The County is trying to resolve the Tucker Road issue. The rest of Brookstone could be developed although retention may be an issue. A few lots could be lost.
