Ordinance No. G-23-05

AN ORDINANCE AMENDING ORDINANCE G-07-29 CONCERNING RATES FOR COLLECTION AND DISPOSAL OF SOLID WASTE BY THE TOWN OF GEORGETOWN, INDIANA

WHEREAS, the Town Council for the Town of Georgetown, Indiana is the legislative body of the Town of Georgetown;

WHEREAS, the Town Council, pursuant to Indiana Code 36-9-30-5.3, entered into a contract for collection and disposal of Solid Waste for the Town of Georgetown, Indiana on December 15, 2022 with services to begin under the contract on January 1, 2023;

WHEREAS, the Town Council, pursuant to Indiana Code 36-9-30, is the entity with authority to establish rates for solid waste collection and services within the Town;

WHEREAS, the Town Council had conducted a rate study on the Solid Waste rates within and for the Town of Georgetown;

WHEREAS, the Town Council for the Town of Georgetown, Indiana, has determined that the rates for solid waste collection with the Town are no longer adequately providing for the costs the Town is incurring to ensure garbage and solid waste collection and disposal; and

WHEREAS, the Town Council, after review and consideration, has determined that the following rates and charges are appropriate for the Town of Georgetown Solid Waste Collection and Disposal:

Commercial	\$52.00

Now, therefore, be it ordained by the Town Council of the Town of Georgetown, Indiana it is hereby ordered as follows:

1. The Town Council hereby sets the following rates and charges for the Town of Georgetown, Indiana for Solid Waste Collection and Disposal:

Single/Multi Family Residences	\$26.00
Commercial	\$52.00

- 2. The Rates and Charges, as approved and adopted herein, shall be owed, each month, by each property owner.
- 3. If any part of this Ordinance shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remainder of this Ordinance.
- 4. The provisions of this Ordinance shall become and remain in full force and effect and until its repeal by ordinance.
- 5. All prior ordinances and parts of ordinances not expressly amended or repealed by this Ordinance shall remain in full force and effect. All prior ordinances and parts ordinances in conflict herewith are hereby repealed.
