NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF GEORGETOWN, INDIANA AS FOLLOWS:

- 1) The Georgetown Town Council hereby wishes to sell the property listed in the attached Exhibit A, by internet sale. Said equipment shall be sold as is and no guarantees to the current condition or operability are provided.
- 2) The Georgetown Town Council hereby wishes to repeal the sale of the Flink Salt Spreader from Resolution R-23-7 and add the Flink Salt Spreader with the sale of an international dump truck and snowplow as a package.
- 3) The Georgetown Town Council hereby wishes to repeal the sale of the reserve of the Spill Dollies from Resolution R-23-7 and sell the items without a reserve.
